TERMS AND CONDITIONS

A. The Responsibility and Duty of the Registered Company

E. Cancellation of Approval

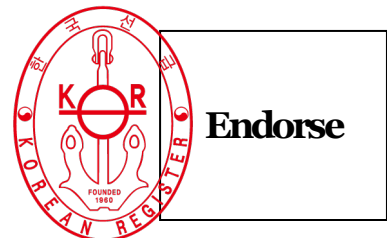
The approval may be cancelled in cases:
